Respected Sir/Madam,

With reference to your application no.: SL-90591-2324 dated 27.12.2022 the school has removed the deficiencies shown in your letter. The point wise statement is given below:-

1. School has applied for fresh affiliation upto secondary level. However, NOC uploaded in the portal is upto 8th standard only.

Ans. **School got the NOC certificate upto secondary level on 06/10/2023. NOC attached herewith: <https://storage.googleapis.com/zmq-cosmonaut/NOC.pdf>**

2. The ownership of land is not clear. As per land certificate uploaded by the school, land is owned by Sushil Kumar, but it is not clear from the said certificate as to how the owner of the land got the ownership i.e. by Sale deed/Conveyance deed/Gift deed/Allotment letter etc. Hence, ownership title cannot be ascertained.

Ans. **School got the revised Land Certificate on 22/09/2023. Land Certificate attached herewith: https://storage.googleapis.com/zmq-cosmonaut/land_certificate.pdf**

3. The school does not have toilets for CwSN students. Hence, school is required to make provision of separate toilets for CwSN students (for boys and girls) on every floor with proper possible infrastructural facilities in accordance with the provisions laid down in RPwD Act.

Ans. **School newly constructed the CWSN toilets for the girls and boys separately on every floor and Ramp to access the upper floors and main entrance. Videography uploaded on the YouTube url attached herewith: <https://www.youtube.com/watch?v=tXmC48UDUI8&feature=youtu.be>**

4. Composite science lab has not been maintained and upgraded as per SOPs/recommended infrastructure and facilities communicated vide Circular No. 11/2022. Exhaust fans, gas pipeline, bins for biodegradable waste/non-biodegradable waste, fire extinguishers, sinks etc. have not been found in the lab. Lab is not properly equipped and does not have seating arrangement for students. Lab is under stocked. It also does not have adequate storage facilities to store the material. It appears to be under sized also.

5. Computer Lab is under sized & is not sufficiently equipped. It has less number of computers than norms.

6. Maths lab is under sized and under stocked. It does not have adequate seating arrangement for students.

7. Library is under sized and under stocked with limited seating arrangement that cannot accommodate 40 students at a time. It also does not have separate reading space for the staff.

8. There is no seating arrangement for the students to play indoor games in the sports room.
